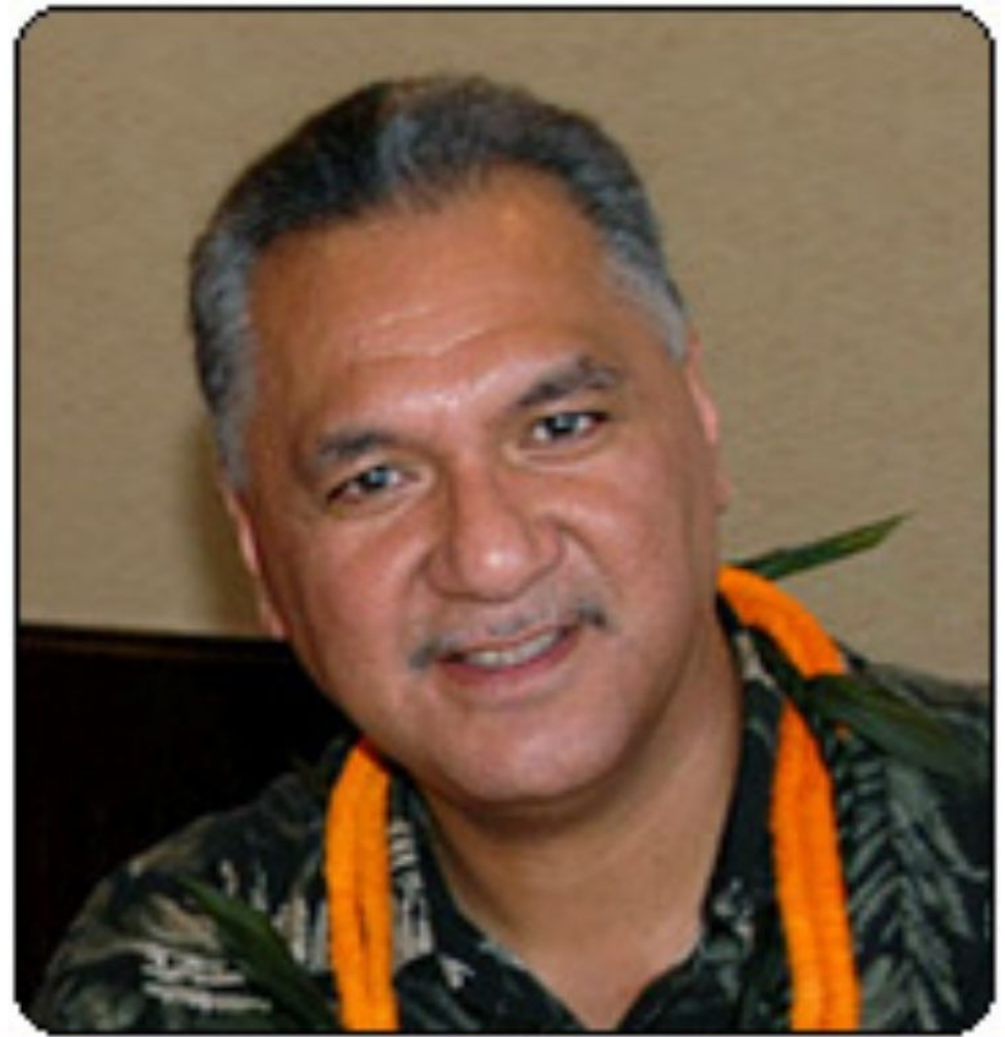


# Paycheck Protection Program Updates

- First round supported employment of 51 million American workers and over 80 percent of small business payroll across all 50 states and territories.
- New round of funding announced last week:
  - \$284 billion toward job retention and certain other expenses.
  - Community financial institutions were able to make First Draw PPP Loans on Monday, Jan. 11 and Second Draw PPP Loans Wednesday, Jan 13.
  - The PPP will be open to all participating lenders soon.
- Set asides available for new and smaller borrowers, borrowers in low- and moderate-income communities, and community and smaller lenders.
- SBA is taking additional steps to ensure increased access to the PPP for minority, underserved, veteran, and women-owned businesses.
