Relevant information should include not only industry experience but also other information such as industry association leadership, experience with economic/business development organizations, Chambers of Commerce, certifications etc. If additional space is needed for the WRITTEN STATEMENT, please use the blank page provided (page 4 in this PDF file) and TYPE the remainder of the WRITTEN STATEMENT. Supporting documents can also accompany the application form.
- **IMPORTANT:** The application must be completed digitally; information must be **TYPED** in the PDF document. Handwritten forms will be returned. Print that page with the signature block, sign the signature block and e-mail that page as an attachment, along with the completed digital application form.
- Individuals who do not have a capability to scan a document should consider using a mobile device such as a smart phone or tablet to take a picture of the document and send the digital image along with the application form.
