Synopsis: This presentation will introduce GeoXO, the NOAA satellite program that will follow the Geostationary Operational Environmental Satellites – R (GOES-R) Series. In the past two years, NOAA has engaged in wide-ranging user needs assessments to inform the observational requirements for this new system and conducted engineering studies and cost assessments to finalize the instrument set and the satellite architecture. The GeoXO Program completed its first technical review, the Mission Concept Review, in June 2021 and was formally approved to enter the "Definition Phase" by the Deputy Secretary of Commerce at Milestone 1 in November 2021. The planned GeoXO constellation will include twin "east" and "west" satellites with an Imager, Lightning Mapper, and Ocean Color instrument, and a third "center" satellite carrying a Hyperspectral Sounder and Atmospheric Composition instrument. The program is currently working toward its System Requirements Review in August and Milestone 2 in December 2022. The first GeoXO launch is targeted for 2032 and the satellites are expected to be operational into the 2050s. This presentation will discuss the GeoXO definition process, mission concept, cost, schedule, along with the plans for formulation, slated to continue through 2025.

This session will provide an overview of what the CSAW Program has to offer, who it is for, some benefits and how to get involved as a co-facilitator.

However, anyone performing P/PM duties are encouraged to obtain their certification. Traditionally, NOAA like other bureaus and agencies, have contracted these classes out to vendors. But this year, NOAA explored a more innovative approach. After much research and planning, the NOAA-wide PMIAA Working Group implemented NOAA's first-ever FAC-P/PM Training and Development Program. This session will outline the planning and implementation phases of the pilot program, as well as lessons learned from the course administrators.
