Department of Commerce FY 2022 EEO Complaints Findings of Discrimination and Corrective Action

The No FEAR Act, as amended, requires the Department to publicly post as well as report on the following information regarding administrative EEO complaints findings of discrimination: the date of the finding; the involved Federal Agency; the law violated; and whether a decision has been made regarding disciplinary action because of the finding.

Section 202 of the No FEAR Act requires that Federal agencies post a notice on their public websites after a finding of discrimination (including retaliation) has been made and all appeals have been exhausted. A notice must be posted for at least one year:
