## Important Transition Information for Grantees

Below is important information for Department of Commerce (DOC) grant recipients and what to expect in the coming months as the Department begins the simultaneous transition to a new grants system (GEMS, powered by eRA) and a new financial management system (BAS). **Action on your part may be required.**

### ***What is a Black Out Period?***

Because the GEMS and BAS (DOC financial system) transitions are software migrations, there will be a period when the legacy systems and the future state systems are unavailable. This time is being referred to as the "blackout" period for processing. **READ THIS ENTIRE COMMUNICATION** for important guidance during the blackout and what end users can expect when the core, mission support systems, are unavailable.

### ***How will this affect current Grantees?***

In order to provide additional flexibilities for grantees during the Department's transition from CBS to BAS, **from September 20, 2023, to October 25, 2023**, the Office of Acquisition Management (OAM) authorizes the following temporary deviation to Section B.02.b.1 of the Department's Financial Assistance [Standard Terms and Conditions](#) (STCs): **"non-Federal entities may time advance payment requests so that Federal funds are on hand for a maximum of 60 calendar days before being disbursed by the non-Federal entity for allowable award costs."**

This temporary deviation is effective September 7, 2023, and expires on November 5, 2023 (60 calendar days from September 7, 2023). **Grantees will not be able to draw down on grants during the blackout window. All advance drawdowns must be done by the beginning of the black out period, September 20<sup>th</sup>, 2023.**

**Note:** For awareness, due to the transition, all future financial and programmatic reports will be sent through the eRA grants system. More information and training will be provided at the appropriate time.

## ***What if I am a Grantee that does not use the ASAP system?***

Any NOAA/EDA Non-ASAP SF-270 requests, to include requesting advance payments, should be submitted by **3PM EDT 9/20/23**. These grantees are being extended the same courtesy of up to 60 days of advance funds as ASAP system users. Non-ASAP grantees should incur expenses for the duration of the blackout window (**9/20/23 – 10/25/23**) and should provide reimbursement documentation after the systems are live.

**More GEMS (Frequently Asked Questions)**

**Q1: What is the difference between GEMS and eRA Commons?**

Grants Enterprise Management Solution (GEMS) is the “modernization and consolidation” effort being undertaken by the Department of Commerce to bring all the different Bureau grant programs under one “roof”. eRA is the platform (application or system) through which we will be administering those grants. eRA is taking the place of Grants Online and other separate applications or systems in which the bureaus are currently managing the transactional work and administration of grants. eRA Commons is module/extension of eRA that is external/grantee/applicant facing where external users interact with DOC staff to conduct business. While eRA replaces Grants Online, eRA Commons compares to the Grants Online’s grantee user access.

**Q2: How do I get assistance troubleshooting eRA Commons registration?**

Users are directed to contact the eRA Service/Help desk **toll free at (866) 504-9552 or (301) 402-7469**. The eRA Service Desk hours of operation are Monday – Friday 7AM to 8PM Eastern Time (closed on Federal holidays).

**Q3: With eRA coming online – will the landscape change so that applicants find out about funding opportunities using Grants.gov and then apply using eRA?**

Grant applicants will continue to apply via Grants.gov just as they are doing now. DOC applicants will **NOT** be using the eRA Commons "ASSIST" module to submit applications directly into the eRA system. However, they **DO** still need to be registered as an organization in eRA Commons because their applications will not be able to be pulled into eRA from Grants.gov for processing unless their organizations are registered in eRA Commons.
