



#### Department of Commerce Minority Business Development Agency (MBDA) Budget Estimate, Fiscal Year 2025 Executive Summary

The FY 2025 MBDA Budget Request totals \$80 million and includes 76 positions. This budget will allow MBDA to continue to implement the Minority Business Development Act of 2021 (P.L. 117-58, "the Act"), which codified the MBDA as a permanent agency with expanded authorities to support minority business enterprises (MBEs). MBDA will continue its efforts to (1) broaden its Rural Business Center Program, which will ensure the Agency's services and tools are available in rural and urban areas; (2) explore the efficacy of MBDA regional offices; (3) expand access to the Agency's Data, Research and Evaluation services, Public-Private Partnership programs and improve the Agency's regional coordination with federal, state, local, and tribal organizations; and (4) strengthen the Agency's network of business centers, which includes MBDA Business Centers, Specialty Centers, and Rural Business Centers. These efforts help ensure minority and underserved entrepreneurs have access to the resources needed to create jobs, advance local economies, and drive the Nation's prosperity. In addition, MBDA will continue to implement its Capital Readiness Program (CRP), which is funded through the U.S. Department of Treasury, State Small Business Credit Initiative (SSBCI), to provide technical assistance to help underserved entrepreneurs across the country to grow and scale their businesses.

## Inflationary Adjustments

MBDA's FY 2025 base includes a total of \$4.231 million and 0 positions to account for the full funding requirement for inflationary adjustments to current programs for MBDA activities. This includes the annualization of the FY 2024 pay raise, and the FY 2025 pay raise of 2.2 percent, as well as an inflationary increases for labor and non-labor activities, including benefits, service contracts, utilities, and rent charges from the General Services Administration (GSA).

## Program Changes:

MBDA plans to carry out the responsibilities of the Act and expand its programs that target unique challenges faced by MBEs. MBDA requests additional resources for the following programs:

**MBDA Business Centers (+\$1.960 million and 0 FTE/0 positions) -** The budget requests an additional \$1.96 million for the MBDA Business Center program to strengthen the existing network of MBDA Business Centers and Specialty Centers. MBDA Business Centers provide technical assistance and business development services, including, business consulting, access to private equity

and venture capital opportunities, and facilitation of joint ventures and strategic partnerships. Support from MBDA's Business Centers contributed to MBEs creating and retaining approximately 18,975 American jobs in FY 2023.

**MBDA Rural Business Centers Program (+\$3.182 million and 0 FTE/0 positions) -** The budget requests an additional \$3.182 million in FY 2025 to advance the MBDA Rural Business Center Program. In FY 2023, MBDA provided \$3.8 million in supplemental grants to existing eligible MBDA Business Centers to establish the Rural Business Centers program. (The supplemental program details can be found in Exhibit 12, page 25.) The funding requested in FY 2025 will allow for MBDA to broaden and expand the existing 19 Rural Business Centers that are currently receiving the supplemental grants and potentially establish additional Rural Business Centers. Additional funding will allow the grantees to expand their reach and have a greater impact in the areas they are currently serving. The Rural Business Center program provides a range of technical assistance and business development services to address critical business development areas. This technical assistance will position rural minority owned enterprises to capture manufacturing opportunities, secure financial capital, create jobs, and fill supply chain gaps in critical supplies and essential goods and services. The technical assistance and business development services will include business consulting, access to private equity and venture capital opportunities, and facilitation of joint ventures and strategic partnerships. This request executes Title III of the Act, which directed the development of rural business centers to provide technical business assistance to minority business enterprises located in rural areas.

**Data, Research, & Evaluation (+\$2.063 million and 0 FTE/0 positions) -** The request will provide an additional \$2.063 million to fully establish and maintain an information clearinghouse and to evaluate the effectiveness of MBDA's programs including the Capital Readiness Program. The information clearinghouse will facilitate the collection and dissemination of MBE data to relevant parties (including business owners and researchers). The clearinghouse will include demographic, economic, financial, managerial, and technical data relating to MBEs. MBDA will fund contracts to operate and oversee the secure online database. MBDA will also fund an impact examination of the MBDA Capital Readiness Program in supporting new venture formation, scaling of businesses, and access to capital, business growth, job creation and wealth. This examination is included in the Department's FY2025 Evaluation Plan.

**Public-Private Partnerships, Minority Business Enterprise Advisory Council (+\$0.948 million 0 FTE/0 positions) -** The budget requests an additional \$948 thousand for the Minority Business Enterprise Advisory Council (MBEAC). This council consists of 19 members who will meet in person twice per year. This program change request will provide funding for travel for the council members, contractor support, and research and publication of findings.

Research stemming from the MBDA MBEAC will contribute to valuable insights, recommendations, and actionable solutions to inform policy, decision-making, and/or specific initiatives related to the council's areas of focus – contracts, capital, domestic & global

supply chains. The results of such research will be well documented, evidence-based, and relevant to the issues or challenges addressed by the council. Some potential outcomes or results that research from the MBEAC may aim to achieve include:

- Policy Recommendations
- Data-Driven Insights
- Best Practices and Strategies
- Impact Assessments
- Stakeholder Engagement
- Evaluation and Monitoring
- Capacity Building
- Public Awareness and Education

Overall, the result of the research stemming from the MBEAC will generate actionable knowledge that informs evidence-based policymaking, fosters collaboration and innovation, and ultimately contributes to positive outcomes for the clients and stakeholders that MBDA serves.

The Council will advise MBDA leadership by:

- Serving as a source of knowledge and information on developments in areas of the economic and social life of the United States that affect socially or economically disadvantaged business concerns; and
- Providing leadership with information regarding plans, programs, and activities in the public and private sectors related to socially or economically disadvantaged business concerns.

**Non-recurring Operational Costs (-\$2.384 million 0 FTE/0 positions) -** To partially offset the requested increases MBDA will reduce contractual support by \$2.384 million. This offset poses no negative performance impacts to MBDA's mission.

#### Goal Statement

The goal of MBDA is to promote the growth, global competitiveness, and the inclusion of minority-owned businesses through data, research, evaluation, partnership programs, and federal financial assistance programs.

MBDA is focused on implementing the vision of the Minority Business Development Act of 2021, which elevated the Agency as a leader in the Federal Government and affirmed equity in business as a national priority. MBDA is turning that vision into a reality by strengthening the organization, expanding reach, and elevating the MBE voice. MBDA will continue to implement the vision of the Act, focusing on scaling MBDA's Rural Business Center Programs; building the data, research, and evaluation work; strengthening public-private partnerships; and sustaining the MBE Advisory Council to help today's businesses by continuing to lay the foundation for tomorrow's businesses to succeed without systemic challenges holding them back.

#### Base Programs

MBDA awards federal financial assistance to operate a network of centers —business centers, specialty centers, rural business centers, and other programs)— to serve millions of MBEs through technical assistance and business development services, which enable:

- Access to capital,
- Access to contracts, and
- Access to markets.

MBDA's Business Centers are designed to assist socially and economically disadvantaged entrepreneurs in starting and growing businesses through counseling, training, and access to capital. Centers are now located in 34 states, the District of Columbia, and Puerto Rico. Additionally, MBDA Business Centers partner closely with other Federal agencies and the private sector to better equip economically or socially disadvantaged entrepreneurs, which includes providing services in different languages. In addition to providing training and counseling services, MBDA Business Centers have placed an emphasis on access to capital, as access to capital remains a significant barrier to socially and economically disadvantaged entrepreneurs sustaining businesses. A large percentage of MBDA Business Centers are affiliated with organizations that are lenders, many of which are Community Development Financial Institutions.

In FY 2023, MBDA explored regional coordination with the goal of creating and strengthening partnerships at the local and state level to amplify MBDA's mission and better connect socially and economically disadvantaged entrepreneurs to MBDA's network of resources. Several approaches are under study including co-locating with Commerce bureaus with an existing regional footprint. This approach shows promise, yielding cost savings and achieving MBDA's goal of enhancing customer experience through regional coordination.

In FY 2023, MBDA expanded its national network from 88 to 131 business centers and programs, increased its reach in rural communities, and launched CRP, the largest technical assistance program of its kind. In FY 2023, the national network helped businesses secure over \$1.2 billion in capital, over \$1.6 billion in contracts, and nearly \$300 million in export deals.

#### Data, Research, and Evaluation

MBDA collects data, commissions research, and disseminates findings for and about MBE's. This includes findings to assist entrepreneurs and prospective entrepreneurs in understanding what is necessary to establish and successfully operate MBEs. MBDA relies on data, research, and evaluation—allowing consumers to gain deep and broad awareness of the current challenges MBEs face. MBDA's repository of evidence-based publications and reports is cataloged to facilitate access.

#### Partnership with Universities and Colleges

MBDA partners with Historically Black Colleges and Universities (HBCUs), Minority-Serving Institutions (MSIs), and Hispanic Serving Institutions (HSIs). The Agency continues to prioritize its partnerships with HBCUs, MSIs, and HSIs, and Tribal Colleges and Universities (TCUs) in several areas, including: 1) research, where the Agency partners with an institution to explore areas that are critical to issues facing MBEs; 2) collaboration, which may permit an exchange of personnel and data between the Agency and the universities; 3) education, where funds may be provided to HBCUs, MSIs, HSIs or TCUs to strengthen academic programs focused on entrepreneurship, 4) business formation, or other areas that are vital to an MBE's success; and 5) technical assistance, where the Agency may enter into a grant or cooperative agreement with an HBCU, MSI, HSI, or TCU to enhance the institutions' ability to serve MBEs, underserved and aspiring entrepreneurs and founders. MSIs may prove critical to MBDA's ability to successfully optimize its research through machine learning, as well as operate rural business centers.

#### Statement of Operating Objectives

Implement the Minority Business Development Act of 2021 (P.L. 117-58, "the Act"), which authorized existing and several new activities to support minority business enterprises (MBEs).

#### **Existing Initiatives**

#### MBDA Business Centers

Utilize federal financial assistance to operate a network of public partnerships that enables the Agency to deliver to MBEs technical assistance and business development services, which can ultimately enable them to have access to capital, contracts, and markets; create and retain jobs; and facilitate the growth of MBEs through trade.

#### MBDA Specialty Centers

MBDA Specialty Centers offer targeted assistance to minority manufacturers to increase the number of "Made in America" products sold domestically and globally. The centers provide technical assistance and business development services to generate increased financing, contract opportunities, and greater access to new and global markets for MBEs. In addition, these centers facilitate access to federal procurement officials and prime contractors throughout the region. MBDA Specialty Centers explore partnerships with other organizations that offer technical assistance programs and services that can strengthen the Agency's existing network of specialty centers.

#### Market Development, Research, and Information

MBDA will coordinate data, research, and evaluation activities with external entities in alignment with Section 100103 of the Act and the Foundations for Evidence-based Policymaking Act of 2018. The Agency relies on data, research, and evaluation to gain a deep and broad awareness of the current challenges MBEs face.

MBDA uses data, research, and evaluation which enables the Agency to discover and exploit opportunities to inform policymaking across the U.S. Government and recommend targeted solutions that strengthen MBEs' likelihood of success.

MBDA focuses its priorities on the following areas:

- (1) Targeted solutions MBDA conducts thorough, quality research in partnership with organizations from the federal, state, local, tribal, private sector, or academia to propose targeted solutions to unique challenges facing MBEs
- (2) Program effectiveness -- MBDA, in partnership with MBEs, federal, state, local, tribal, private sector, or academia community organizations evaluates the effectiveness of Agency and other federally funded programs to ensure that they are addressing the unique needs of MBEs
- (3) Efficacy strengthen and improve MBDA's data, research, and evaluation capabilities across its workforce
- (4) Partnership foster and enhance university-industry collaboration and engage with the academic research community and international partners.

#### Rural Business Centers

There are nearly 10 million MBEs in the United States, of which there are more than 544 thousand located in rural areas. Rural America covers a vast amount of land across the United States, making geographical distances a substantial barrier to economic success. Rural industry is not exclusively agricultural. Only one in five non-metro counties is dependent on agriculture; and the largest sector by employment in rural communities is the service sector. The diversity of rural economies means that there is a diverse need for rural businesses.

In FY 2023, MBDA piloted a program to establish new rural business centers aimed at MBEs that are in lower-density regions of the United States, particularly those that may not have reasonable access to traditional MBDA Business Centers or MBDA Specialty Centers. This pilot program provided \$3.8 million through supplemental grants to eligible existing MBDA Business Centers. This provided for 21 supplemental grants, of which, 19 grantees accepted the award. Eligibility for a Rural Supplement included Business Centers located in a state with:

- i. a rural minority population of at least 200,000,
- ii. a rural population that is at least 20% minority, or
- iii. at least one rural majority-minority county based on U.S Census Bureau data

The expectation for the Business Centers that were awarded the supplemental grant is they will expand their reach in providing technical assistance to Rural Minority Business Enterprises (RMBE) in their state. MBDA will facilitate the collaboration between Rural Supplement recipients and relevant federal departments (such as USDA and SBA). Awardees are required to establish a physical presence in one or more rural areas of their state to offer services to RMBEs located more than 50 miles from an existing Business Center. Rural Supplement recipients will apply funding to strengthen the entrepreneurial ecosystem and support for RMBEs regarding issues such as:

- Broadband internet accessibility and adoption
- · Digital literacy skills
- Leveraging e-commerce
- Securing financial capital
- Securing public and private contracts
- Facilitating entrepreneurship in rural areas
- Creating jobs in rural areas
- The promotion of agriculture
- · Climate adaptation
- Helping RMBEs meet gaps in the supply chain of critical supplies and essential goods and services for the United States
- Improving the connectivity of rural businesses through transportation and logistics
- · Any other issue relating to the unique challenges faced by RMBEs

MBDA will conduct semiannual (April 30, 2024) and annual (October 30, 2024) performance reports to determine the efficacy of the program. The results and data gathered from these reports will demonstrate the impact of our current business centers' ability to reach Rural Minority Business Enterprises (RMBE) and provide support to those that may otherwise not receive technical assistance. The supplemental data will provide insights into the following: the reach of the those who service rural areas; how many engagements they were able to achieve during the funding period; how many new business were formed or scaled as a result of the funding; how many business and financing opportunities were identified along with legal assistance referrals to existing and/or prestartup RMBEs; number of formal partnerships were established in support of the rural supplement program priorities; and the total principal value of approved loans, lines of credit, trade credit, subordinated debt, surety bonding, bonds used to raise capital for RMBEs, leases, equity investments, specialized industry financing, export letters of credit, capital formation, assets under management, and/or other financial agreements secured for RMBE clients.

#### **Federal Coordination**

MBDA provides entrepreneurship education development activities using federal financial assistance grants to partner with public and private sector entities and educational institutions to support opportunities for business and management education, apprenticeships, entrepreneurship training, and related activities for the benefit of socially or economically disadvantaged individuals.

Through the continued development and implementation of a Public-Private Partnerships Program and the Minority Business Enterprise Advisory Council, MBDA staff will be better positioned to provide the Under Secretary and the Department with direct industry information regarding plans, programs, and activities in the public and private sectors as described in the Act.

MBDA will work with other federal agencies to share and collect data which describes the state of MBEs ranging from capital accumulation and business formation to labor development and the MBE role in regional economic development. MBDA will also disseminate information promoting minority business development to the public and strategic partners operating within the minority business community. This will be accomplished by leveraging constituency outreach including minority-owned businesses, minority serving institutions, trade associations, the academic community, community development organizations, private sector corporations, as well as federal, state, and local government officials.

In an effort to support minority business development, MBDA uses the Agency's website, social media accounts, strategic alliance portfolios, and national conferences to provide access to information and network resources.

#### FY 2025 Agency Priorities

#### Expand Access to Capital

- Continue to execute the CRP with current funding through FY 2026
- Build on FY 2024 initiatives to deploy new access to capital models
- Build on MBDA's FY 2024 efforts to establish new partnerships with DOC bureaus and other federal agencies.

Implement the Minority Business Development Act of 2021

- Build on MBDA's FY 2024 efforts to invest in rural communities (MBDA Rural Business Centers)
- Build on MBDA's efforts to create operational capability, including exploring regional coordination to strengthen MBDA's network of resources
- Build on MBDA's FY 2024 efforts to implement a multi-year strategic plan.

Advance Equity

- Build on MBDA's FY 2024 efforts to advance equity (Establish specialty centers focused on women, native and indigenous, and veteran businesses)
- Build on MBDA's FY 2024 efforts to become the Federal Government's Premier Data and Research Agency for minority businesses.

#### Program Change: MBDA Rural Business Centers Program

**MBDA Rural Business Centers Program (+\$3.182 million and 0 FTE/0 positions) -** The budget requests an additional \$3.182 million in FY 2025 to advance the MBDA Rural Business Center Program. In FY 2023, MBDA provided \$3.8 million in supplemental grants to existing eligible MBDA Business Centers to establish the Rural Business Centers program. (The supplemental program details can be found in Exhibit 12, page 25.) The funding requested in FY 2025 will allow for MBDA to broaden and expand the existing 19 Rural Business Centers that are currently receiving the supplemental grants and potentially establish additional Rural Business Centers. Additional funding will allow the grantees to expand their reach and have a greater impact in the areas they are currently serving. The Rural Business Center program provides a range of technical assistance and business development services to address critical business development areas. This technical assistance will position rural minority owned enterprises to capture manufacturing opportunities, secure financial capital, create jobs, and fill supply chain gaps in critical supplies and essential goods and services. The technical assistance and business development services will include business consulting, access to private equity and venture capital opportunities, and facilitation of joint ventures and strategic partnerships. This request executes Title III of the Act, which directed the development of rural business centers to provide technical business assistance to minority business enterprises located in rural areas.

#### **Performance Measures**

MBDA will develop and provide performance measures for subsequent budget requests and annual performance plans and reports. Performance outcomes will be provided in the first semi-annual report from the FY 2023/2024 pilot program in Q3 of FY 2024. Customers/clients' partnerships served, extent of program participation, and services delivered must be determined prior to the development of program performance measures. Additional measures for examination will track event attendance participation, satisfaction surveys and/or real time polls, and targeted training offerings. Advanced gauges of the program will be developed to analyze return on investment and effectiveness of service delivery functions.

**Data, Research, & Evaluation (+\$2.063 million and 0 FTE/0 positions) -** The request will provide an additional \$2.063 million to fully establish and maintain an information clearinghouse and to evaluate the effectiveness of MBDA's programs including the Capital Readiness Program. The information clearinghouse will facilitate the collection and dissemination of Minority Business Enterprise (MBE) data to relevant parties (including business owners and researchers). The clearinghouse will include demographic, economic, financial, managerial, and technical data relating to MBEs. MBDA will fund contracts to operate and oversee the secure online database. MBDA will also fund an impact examination of the MBDA Capital Readiness Program in supporting new venture formation, scaling of businesses, and access to capital, business growth, job creation and wealth. This examination is included in the Department's FY2025 Evaluation Plan.

#### **Performance Measures**

MBDA will develop and provide performance measures for subsequent budget requests and annual performance plans and reports once approvals for the information clearinghouse, the data warehouse, and agreements for the data visualization service are cleared. A functional and supported information clearinghouse will provide the capacity to begin storing, tracking, organizing, and managing inputs for the performance measures.

Measures for examination will track data sources integrated with geospatial tagging; analytical and data visualization products released; number of published papers, data sets, and factsheets; and number of program evaluations. Advanced gauges of the program will be developed to analyze return on investment and effectiveness of service delivery functions.

Overall, the result of the research stemming from the MBEAC will generate actionable knowledge that informs evidencebased policymaking, fosters collaboration and innovation, and ultimately contributes to positive outcomes for the clients and stakeholders that MBDA serves.

The Council will advise the leadership of the Agency by:

• Serving as a source of knowledge and information on developments in areas of the economic and social life of the United States that affect socially or economically disadvantaged business concerns; and

## Summary Description of Tribal Consultations:

In accordance with the Minority Business Development Act of 2021 (P.L. 117-58), SEC. 100702. This includes Tribal Governments; those recognized governing body of any Indian or Alaska Native tribe, band, nation, pueblo, village, community, component band, or component reservation, individually identified (including parenthetically) in the list published most recently as of the date of enactment of this division pursuant to section 104 of the Federally Recognized Indian Tribe List Act of 1994 (25 U.S.C. 5131).

## Summary Description of Tribal Input:

The Minority Business Development Agency has no regulatory consultation activities to report in accordance with Executive Order 13175 of November 6, 2000. In response to a new MBDA Tribal Program initiative, an upcoming tribal consultation is scheduled for April 2024.

#### **Overview of Bureau Accomplishments**

The President signed the Minority Business Development Act of 2021 (Act) on November 15, 2021 (P.L. 117-58, the Act"), which codified the Minority Business Development Agency (MBDA) as a permanent agency and authorized several new activities to support MBEs. MBDA awarded six new Minority Business Centers (MBCs) in South Carolina, Indiana, Oregon, Arkansas, Wisconsin, and Utah expanding the footprint from 28 states to 34 states, including the District of Columbia and Puerto Rico. MBDA's programming at the national level and through its grant awardees (i.e., business centers, specialty centers, rural business centers, and Broad Agency Announcements (BAA)) focus on key drivers to MBE's success in the U.S. economy: access to capital, contracts, and domestic and global markets. MBDA's strategic focus is to maximize the domestic and global competitiveness of MBEs resulting in U.S. job creation, innovation advances, increases in manufacturing, exports, and global supply chains. MBDA continued 29 Broad Agency Announcement grants that support and complement DOC initiatives. Additionally, MBDA awarded two new BAA grants for access to capital/innovative finance solutions and seven BAA grants for its Minority Colleges and Universities program to provide funding to MSIs, for the establishment and growth of student entrepreneurship programs.

#### Access to Capital

By far the most important aspect of developing a business, and often the most difficult to achieve, is access to capital and financial management. MBDA Business Centers' staff offer extensive experience in commercial lending and banking, financial, credit and risk analysis, and general financial counseling. In FY 2022, MBDA laid the foundation for the establishment of the Treasury's SSBCI program and in FY 2023 issued a BAA on alternative financing for MBEs. This program built upon a directory of MBE-friendly capital providers and matched MBEs to those providers. In FY 2023, the agency launched an SSBCI grant competition, branded as CRP, and received more than 1,000 applications for 43 awards. From FY 2023-2026, the \$125M program will enable CRP awardees to launch and operate business incubators or accelerators designed to prepare minority and other underserved entrepreneurs to secure capital from the \$10 billion SSBCI and other capital sources.

#### Access to Contracts

MBDA Business Centers provide procurement assistance to help minority-owned firms do business with major corporations, federal, state, and local governments. In FY 2023, MBDA prioritized influencing policy that supports MBE inclusion in contracts by participating in the federal procurement Infrastructure Investment and Jobs Act (IIJA) Council and coordinating with agencies' Offices of Small and Disadvantaged Business Utilization. MBDA is also convening federal partners to advocate for MBE inclusion in federal contracting, in alignment with E.O. 13985 into FY 2024 and FY 2025.

#### Access to Markets

Increasing market share through the identification of new markets or increasing client customer base in an existing market is a goal for each of the business centers. Services include private and public sector procurement assistance, teaming, joint ventures, domestic and global supply chain management, and specialized certification assistance including the 8(a) program, MBE, as well as Small Disadvantaged Business. The Business Centers also assist with market research and market plan development on emerging industries and markets such as electronic vehicles, climate, clean green energy, construction, healthcare, and high-speed rail, just to name a few.

#### **Global Business Development**

For decades MBDA has promoted exporting as a business growth strategy for MBEs. Minority firms are a key component of the U.S. international trade economy, are uniquely qualified, and have a competitive advantage to enter global markets because of their linguistic and cultural ties. MBDA is partnering with the International Trade Administration (ITA), Global Diversity Export Initiative and the ITA national network of U.S. Export Assistance Centers to share global business resources and strategies to assist MBEs.

#### Data, Research, and Evidence

In FY2023, as part of the Agency's Learning Agenda, MBDA initiated exploration of the question, "What are the most effective approaches to increase capital availability to minority businesses?". MBDA also initiated two additional studies as required under the Act on (i) ways in which minority businesses can meet the gaps in the supply chain of the United States, and (ii) a study on opportunities for providing alternative financing solutions to minority businesses. The results of the studies are anticipated to improve advocacy and awareness among private and public stakeholders, as well as inform the development and design of future MBDA programs. MBDA produced new minority business fact sheets by race/ethnicity groups and 50 minority business breakouts by state. MBDA initiated geospatial mapping and visualization.

#### Planned Actions through FY 2025

In FY 2022, MBDA began implementing the Act by developing the Agency's long-term strategy to expand as a permanent federal agency with an Under Secretary and meet the Agency's mission on a greater scale. As MBDA evolves, the Agency looks to focus on four strategic pillars: 1) Expand Services; 2) Research and Data; 3) Intergovernmental Coordination, Marketing, Communications, and External Affairs; and 4) Build Capacity. For FY 2025 and beyond, MBDA aims to further broaden its network of business centers to expand its footprint in more states and territories, expand the Rural Business Center program, and coordinate digital-enabled tools to offer greater availability of services for MBEs. MBDA will support its programs by investing in additional technology, increasing the average awards to centers, and establishing a national network of business centers in every U.S. state and territory.

The Act mandates MBDA to implement a new Parren J. Mitchell Entrepreneurship Education Grant program. This program makes annual awards to institutions of higher education to develop curricula that includes business management, marketing, leadership, and other entrepreneurial skills and trainings. This program adds to MBDA's current partnerships with minority serving higher education institutions and supports MBDA's goal to inspire the next generation of minority businesses and entrepreneurs.

MBDA's pilot grants for the Enterprising Women of Color initiative, Entrepreneurship for Formerly Incarcerated Persons projects and Inner-City Innovation Hub projects were extended for one year in FY 2023. Evaluation of best practices and lessons learned during FY 2024 will inform the program portfolio for FY 2024-2025.

#### Analysis of Performance Indicators

In FY 2022, MBDA initiated a new set of measures and targets to better align with the Department's Strategic Plan and reflect improved tangible results generated through MBDA programs, activities, and initiatives. The new measure, Economic Benefits to MBEs, aggregates (a) dollar value of contracts, (b) dollar value of financing, (c) dollar value of capacity investments, (d) and increase in sales. Whereas, in prior years MBDA tracked only items (a) and (b), resulting in an underreporting of performance of MBEs served in retail industries and areas that increase MBE equity. MBDA continues reporting MBE clients served and modified jobs by including jobs created and jobs retained.

#### **Explanation of Trends**

The agency received an increase of \$15M in FY 2023, for a total appropriation of \$70M, that supported the expansion of new business centers and initiatives. Performance for FY 2023 exceeded its goals at \$5.41B for Economic Benefit to MBEs and the agency 18,975 for jobs created and retained. In observation and based on anecdotal input from the national network of MBDA Business Centers, in FY 2023, operators of the business centers have acknowledged that their clients continued to be impacted by the pandemic and issues related to supply chains, loss of customers, loss of staff, and in some instances starting over. However, there is a positive outlook related to some industries that benefited from the pandemic and the IIJA and E.O. 13985.

#### Explanation of Targets for FY 2024 and FY 2025

MBDA performance measures are based on the summation of its program performance as outlined in the cooperative agreements through business centers, pilots, and programs. Individual program awards contribute in whole or in part to current year actual performance and projected future year performance targets. MBDA is cognizant of needed lead and lag times for programs to initiate operations and build momentum that result in service outputs, outcomes, and impact. As such, MBDA has adjusted performance targets for each program award that originates in FY 2024 and FY 2025, as well as those incumbent programs that continue through FY 2024 and FY 2025. Performance targets that reflect a rise are due to the increase in existing programs, such as the Business Centers and the addition of new programs, such as the Innovative Finance/Access to Capital pilot, based on alignment with MBDA budgetary requests. In FY 2025, MBDA also anticipates expanding its Business Center programs its Rural Business Center program.

#### **Progression of the Performance Indicators**

MBDA has continued to improve upon the way it captures various performance elements within its portfolio of grant investments. While the Agency has key pillars that it reports to OMB, it has also continued to expand upon qualitative measurements, such as number of strategic alliances, outreach and awareness, and strategic facilitated actions. Additionally, the Agency continues to coordinate with the Office of the Chief Information Officer on regular sprints to ensure that performance dashboards accurately reflect data that is useful and informative for future investments.

#### Performance Data Validation and Verification

Performance data on all MBDA program performance that are submitted to OMB are tracked through a cloud-based analytics software. The data is entered by business center staff and is validated by MBDA Program Analyst staff to ensure accuracy. This is a formal process that requires multiple validation points and documentation that must be adhered to for 100% of contracts and financial transactions, and job creation. The confirmed performance data in this system is used to determine "Satisfactory or Above" performance, in a given award cycle/calendar year. It should be noted that the business centers start date is off cycle with the fiscal year for the agency.
