SUBJECT:	Contractor Reporting of Biobased Products – FAR 52.223-2

Background:

Section 9002 of the Farm Security and Rural Investment Act of 2002, as amended by the Food, Conservation, and Energy Act of 2008, Pub. L. 110-246 (the Farm Bill) requires Federal Agencies to give a procurement preference to USDA-designated biobased products. In addition, the legislation requires each procuring agency to report annually on the types and dollar amount of biobased products that their contractors purchase under service and construction contracts.

On February 21, 2012, President Obama issued the Presidential Memorandum, "Driving Innovation and Creating Jobs in Rural America through Biobased and Sustainable Product Procurement." In accordance with Section 5 of the Memorandum, the FAR Council published a final rule (77 FR 23365) implementing the reporting requirement found in the Farm Bill. FAR Clause 52.223-2, Affirmative Procurement of Biobased Products Under Service and Construction Contracts, became effective May 18, 2012.

Purpose:

The purpose of this procurement memorandum is to require Bureau Procurement Officials (BPOs) to take necessary actions to implement and report on Contractor use of Biobased products as required in FAR Clause 52.223-2.

Required Actions:

As part of the responsibilities for promoting and implementing DOC's Green Procurement Program, the following actions are required:

For new solicitations and resulting contracts with requirements for biobased products, Contracting Officers shall include FAR Clause 52.223-2. The Contracting Officer shall insert the name, phone number, and email address of the environmental point of contact in FAR Clause 52.223-2. The Contacting Officer shall give each contractor the reporting template (Attachment B) instructing them to submit the completed forms to the environmental point of contact.

- For existing contracts entered into on or after May 18, 2012, that contain clause 52.223-2, Contracting Officers shall give each contractor the reporting template (Attachment B) instructing them to submit the completed form to the environmental point of contact, Greg Falzetta, at GFalzetta@doc.gov by October 31, 2012, with a copy to the Contracting Officer.
- If a Contractor has already reported on its biobased products to the bureau, please forward to the environmental point of contact, Greg Falzetta, at GFalzetta@doc.gov so he may compile the data into the reporting template.
- Contracting Officers shall have the responsibility to enforce FAR Clause 52.223-2. If contractors have failed to report to the designated environmental point of contact leading up to October 31, 2012 it is the responsibility of the Contracting Officer to follow up.

Attachment A: FAR Clause 52.223-2

AFFIRMATIVE PROCUREMENT OF BIOBASED PRODUCTS UNDER SERVICE AND CONSTRUCTION CONTRACTS

(a) In the performance of this contract, the contractor shall make maximum use of biobased products that are United States Department of Agriculture (USDA)-designated items unless—

(1) The product cannot be acquired—

(i) Competitively within a time frame providing for compliance with the contract performance schedule;

(ii) Meeting contract performance requirements; or

(iii) At a reasonable price.

(2) The product is to be used in an application covered by a USDA categorical exemption (see 7 CFR 3201.3(e)). For example, all USDA-designated items are exempt from the preferred procurement requirement for the following:

(i) Spacecraft system and launch support equipment.

(ii) Military equipment, *i.e.*, a product or system designed or procured for combat or combatrelated missions.

(b) Information about this requirement and these products is available at http://www.biopreferred.gov.

(c) In the performance of this contract, the Contractor shall-

(1) Report to the environmental point of contact identified in paragraph (d) of this clause, with a copy to the Contracting Officer, on the product types and dollar value of any USDA-designated biobased products purchased by the Contractor during the previous Government fiscal year, between October 1 and September 30;

(2) Submit this report no later than-

(i) October 31 of each year during contract performance; and

(ii) At the end of contract performance; and

(3) Contact the environmental point of contact to obtain the preferred submittal format, if that format is not specified in this contract.

(d) The environmental point of contact for this contract is:

[Contracting Officer shall insert full name, phone number, and email address. In addition, the Contracting Officer may include the agency website for reporting.]
