#### d) The purpose that the system is designed to serve

FPNG provides USPTO customers a modern payment system. FPNG provides services to the public and internal facing functionality that will enable USPTO employees to support customers. FPNG has interfaces to various USPTO systems and also with the U.S. Treasury, which includes Pay.Gov and OTCNet services.

#### e) The way the system operates to achieve the purpose

FPNG allows internal and external users to manage payment accounts, perform profile updates, and make payments for USPTO goods and services, etc., via the FPNG User Interface (UI). It also provides all functionality related to managing payments and replenishing and transferring of deposit account balances.

# f) A general description of the type of information collected, maintained, use, or disseminated by the system

The types of information collected, maintained, used, or disseminated by the system include public users' names, street addresses, e-mail addresses, and telephone numbers.

### g) Identify individuals who have access to information on the system

Individuals who have access to information on the system are authorized USPTO personnel and external customers for viewing and managing their accounts.

# h) How information in the system is retrieved by the user Information is retrieved via the FPNG UI.

#### i) How information is transmitted to and from the system

Communications utilize a minimum of TLS 1.1 with FIPS 140-2 compliant algorithms to provide transmission confidentiality and integrity for all connections outside the system boundary. The externally-facing VIPs supporting FPNG that exist are configured to only support TLS 1.1 and TLS 1.2.
